1. Call to Order/Welcome/Introductions:

- Cindy Edwards called the meeting to order at 9:36 a.m.
- New board member Alysia Pack was welcomed representing Isle of Wight County
- Rose Brown was recognized for 26 years of service

2. **Public Comments:**

- There were no public comments

3. **Approval of Minutes/Outcomes:**

Board of Director's Meeting: November 11, 2023

Outcome: Upon a ***motion*** made by Vicki Wiggins-Pittman and seconded by Toni Brown, the outcomes of the November 11, 2023, meeting were approved with a correction changing the Vice President from Toni Brown to Lula Holland

4. **Executive Director's Report:**

- Mr. Peratsakis thanked all for thoughts and prayers for Board Clerk Darlene Rawls who is recovering from brain surgery
- Mr. Peratsakis noted the absence of Directors Andrew Jurewicz who is attending a Finance Director's Meeting and Staci Young who is conducting ASSIST suicide training
- Mr. Peratsakis congratulated Brandon Rodgers on being promoted to Associate Executive Director of Western Tidewater CSB
- Mr. Peratsakis encouraged all to review the program highlights included in the Board packets

5. **OLD BUSINESS:**

- Employment and Recruitment Update
 - The current number of WTCSB full-time employees is 760
 - 46 employees have been hired and 30 terminated/separated
 - There are 120 vacancies
 - 143 interviews have been conducted since the last board meeting
- Same Day Access (SDA)
 - Staff performed 337 initial screenings
 - Last year's data shows 2,203 initial screenings and almost 1800 intakes
- Peer Supports:
 - The agency currently employs 36 peers
 - 15 are certified and registered
 - 17 are certified
 - Peer support is currently being provided to over 100 consumers
 - Peer providers have billed 76 consumers
- Reimbursement:
 - The General Assembly increased reimbursement rates approximately 10%
 - This results in an additional \$238,000 for the remainder of FY24 and an extra half million in FY25
- Auxiliary Grant Increase:
 - Rate increase should result in \$340,000

6. **NEW BUSINESS**

- 2025 General Assembly Legislative Issues – Brandon Rodgers reviewed “hot button issues”
 - HB608 and SB34 propose authority be given to ER physicians to execute a TDO – VACSB strongly opposes this as it is not an independent evaluation of the individual’s needs and rights
 - HB37 – Loan Repayment Program for mental health professionals – VACSB is advocating for changes in language
 - HB224 regards mental health awareness training in public schools and would allow the Board of Education to determine the appropriate age for a child to receive mental health education – this is being monitored by VACSB
 - HB426 could remove requirements or offer alternative requirements for individuals to become licensed and is being actively opposed
 - HB515 would grant the Commissioner of DBHDS the ability to discharge an individual from a mental health institution without consent of the CSB and is being actively opposed
 - HB822 and HB823 relate to ECOs and TDOs and alternative transportation and would place custody of the individual with the transportation provider – this is being opposed
 - HB1246 supports training law enforcement on handling individuals with autism spectrum disorders and is being supported
 - HB1269 reduces the impact of barrier crimes on individuals seeking employment and is being supported
- Legal Issues
 - Board Attorney Matt Hull educated board members on legal issues:
 - Civil and Criminal Trespass
 - Firearms in buildings
- Right Help, Right Now funding
 - There is an additional \$85 million in grants to localities in 2025 and \$89 million in 2026
 - \$110 million in 2025 and another \$110 million in 2026 for behavioral health and substance abuse
 - \$990 million in 2025 and another \$900 million in 2026 for Developmental Disabilities
 - Crisis Funding:
 - \$10 million for mobile crisis teams
 - \$3 million for first responders
 - \$72 million in 2025 and \$42 million in 2026 to build out crisis programs across the state
 - \$9 million for STEP VA
 - \$42 million for children’s mental health
 - \$7 for peer wellness
 - \$2 million for adolescent substance use disorders
 - CSBs will see more emphasis on gambling addiction
- Highlights of the Governor’s new funding initiatives:
 - \$150 million to support comprehensive crisis system
 - \$15 million for School Based Mental Health
 - \$7.9 million for implementation and expansion of VA Mental Health Access Program for ages 0-5

- \$4.7 million for alternative transportation and custody services
- \$8.5 million for salary increases in state facilities
- \$1.5 million for workforce initiatives at state facilities
- \$60 million for DBHDS infrastructure improvements
- Initiatives to support Right Help, Right Now initiatives:
 - \$150 million to eliminate the Priority 1 waiting list for Developmental Disability waiver slots
 - \$10 million to the Department of Education and State Council for Higher Education for Virginia to support access to mental health services
 - \$10 million to enhance the Behavioral Health Loan Repayment Program to ensure students to join the behavioral healthcare workforce
- Possible partnership with VDSS:
 - Sarah Rexrode informed the board of the Governor's Kinship Placement initiative for foster care
 - Mr. Peratakis and Rufus Darden will participate in a call to Steven Wade
- Wait Time Data Question
 - Ms. Rexrode questioned wait times for services – both for individual counseling and psychiatry
 - Current wait times for an assessment is no longer than a week
 - Psychiatry has a wait time of 30 days
 - Brandon reminded all of the availability of Same Day Access at Northgate 5 days per week and one day per week in Franklin and addressed plans for expansion of this service
 - The Crisis Receiving Center is available 24/7
 - Can handle emergencies and non-emergencies
 - Walk in/drop off/transportation available
 - Available peer support, licensed counselors, other mental health professionals and nursing staff, and a psychiatric nurse practitioner who can prescribe in an emergency
- Permanent Supportive Housing
 - WTCSB will have 77 units available by mid-year
 - 29 individuals are currently housed and 3 referrals are being processed
 - Supportive Housing Institute requires partnership with a developer – WTCSB was awarded a 76-hour training course on this
 - Hampton/Newport News CSB received \$300,000 which will be included in apartment complexes in Northern Suffolk
 - Another grant opportunity is available and WTCSB is working with a development on a new project with 10 units set aside for PSH
 - The development will include office space for onsite staff
- AWARDCO:
 - Platform that streamlines and enhances employee recognition from peers and/or management
 - Cloud based and partners with Amazon
 - Provides an extensive reward catalog
 - Can be monetary or non-monetary
 - Offers real-time recognition
 - Mobile Accessibility
 - Reporting and analytics

- Automated Celebrations
- Performance Management Integration
